We are asking all parents and guardians whose children go to a school in Bury and have a statutory entitlement to Free School Meals to complete this form. We will then be able to confirm whether the school is entitled to claim the Pupil Premium for your child which is extra to the infant free school meal initiative

Any qualifying family that registers their eligibility by simply completing this form will help raise Pupil Premium money for the school following a government commitment to pay schools currently £1,300 per year for each primary age child and £935 per year for each Secondary age child registered. This is extra money the school can receive and use specifically to fund new equipment, more Teaching or Support staff, or for any additional resources necessary to benefit the child's educational outcomes.
